

Fast Track To Miami Sweepstakes Official Rules

The Fast Track To Miami Sweepstakes (“Sweepstakes”) is subject to the full Terms and Conditions of the Emissions Recall 67A Rewards Program (the “Offer”) offered by Cummin Inc. (the “Sponsor”), and the terms set forth below. By participating in the Sweepstakes as set forth herein you are bound by the Offer Terms and Conditions and these Sweepstakes Official Rules.

BY ENTERING (OR OTHERWISE PARTICIPATING IN) THE SWEEPSTAKES, YOU AGREE TO THESE OFFICIAL RULES, WHICH ARE A BINDING CONTRACT, SO READ THEM CAREFULLY BEFORE ENTERING. WITHOUT LIMITATION, THIS CONTRACT INCLUDES INDEMNITIES TO THE OFFER ENTITIES FROM YOU AND A LIMITATION OF YOUR RIGHTS AND REMEDIES.

1. **ELIGIBILITY:** The Sweepstakes is available to any individual who is eligible to participate in the Offer provided that individual has not met the Offer Claim limits, as set forth in the Offer Terms and Conditions. The Offer Entities, their immediate family members (spouse, partner, parents, legal guardians, in-laws, grandparents, siblings, children and grandchildren and their respective spouses) and those living in the same household as such individuals (whether legally related or not) are not eligible to participate in the Sweepstakes or win a prize. Void outside of the United States and where prohibited by law. All federal, state, and local laws and regulations apply. By participating in the Sweepstakes, you unconditionally accept and agree to comply with and abide by these “Official Rules”, the Offer Terms and Conditions, and the decisions of Sponsor, including the interpretation of these Official Rules, administration of the Sweepstakes, selection of the winners, and Sponsor’s exercise of discretion, which will be final, non-appealable, and binding in all respects.
2. **TIMING:** The Sweepstakes begins at or about 12:00 p.m. Eastern Time (“ET”) on June 1, 2026 and ends at 11:59 p.m. ET on July 31, 2026 (the “Sweepstakes Period”). The Administrator’s computer is the official clock for the Sweepstakes.
3. **HOW TO ENTER:** During the Sweepstakes Period, follow the instructions set forth in Section 3 of the Offer Terms and Conditions to have Recall 67A maintenance performed on your Truck at a Dealership, visit the Website, and complete and submit an Offer Claim to receive one (1) entry into the Sweepstakes, subject to the limit below. Recall 67A maintenance must have been completed during the Service Period, and your Offer Claim must be submitted during the Sweepstakes Period to be eligible for entry into the Sweepstakes.

The Offer Entities are not responsible for technical difficulties of any kind, or for false, incorrect, changed, incomplete or illegible contact information.

LIMIT: One (1) entry per person during the entire Sweepstakes Period, regardless of number of valid Offer Claims submitted during the Sweepstakes Period. If an entrant has reached the Offer limit set forth in the Offer Terms and Conditions prior to the Sweepstakes Period, such entrant is not eligible to enter the Sweepstakes. Any entries from ineligible participants will be null and void.

4. **SWEEPSTAKES DRAWING:** On or about September 1, 2026, the Administrator will conduct a random drawing to select five (5) potential winners from among all eligible entries received in accordance with these Official Rules.
5. **ODDS:** Odds of winning a prize depend on the total number of eligible entries received during the Sweepstakes Period.
6. **WINNER NOTIFICATION/PRIZE CLAIMING:** The potential winners will be notified via email using the information provided on the Offer Claim in a commercially reasonable time after the drawing. The Offer Entities are not responsible for and shall not be liable for incorrect, changed, or illegible contact information or for electronic communications that are undeliverable as a result of any form of active or passive filtering, or insufficient space in a potential winner's email or other account to receive messages. Offer Entities are not responsible for late, lost, intercepted, misdirected, or unsuccessful efforts to notify a potential winner. Notification is deemed to have occurred immediately upon the sending of an email. As part of the winner notification process, each potential winner will be required to sign and return a declaration of eligibility/release of liability/prize acceptance agreement ("Declaration"), within seven (7) days of date of notification, as a condition of receiving a prize. If any notification (including the Declaration) is returned as rejected, faulty, unclaimed or returned as undeliverable to a potential winner; or if any potential winner cannot be contacted within a reasonable time period, fails or refuses to sign and return the Declaration within the required time period, and/or a potential winner is ineligible or otherwise fails to fully comply with these Official Rules; such potential winner will be disqualified and an alternate will be selected at random from among all remaining eligible entries, up to three (3) alternates, after which the applicable prize will remain un-awarded. A potential winner becomes a "winner" only after verification of eligibility by Sponsor.

In the event a selected winner is a resident of Alabama or Nebraska and under the age of nineteen (19), a parent or legal guardian may be required to also sign the Declaration in order for such winner to be qualified to receive the prize.

7. No more than the stated number of prizes will be awarded. If, for any reason, more bona fide winners come forward seeking to claim prizes in excess of the number of prizes set forth in these Official Rules, the winners of the advertised number of prizes available may be selected in a random drawing from among all persons making purportedly valid claims for such prizes. Inclusion in such drawing shall be each entrant's sole and exclusive remedy under such circumstances.
8. **PRIZES/PRIZE RESTRICTIONS:**

Five (5) Prizes: Each prize is a four (4) day/three (3) night trip for two (2) people – the winner and one (1) guest – to Miami, Florida. Trip includes: round-trip coach class air transportation for winner and guest from a major commercial airport near the winner's residence (as determined by Sponsor) to Miami, FL, three (3) nights standard hotel accommodation (single room/double occupancy) at a Sponsor-selected hotel in or near Miami, FL; ground transportation for the winner and guest while in Miami, FL will be organized from the airport to and from the hotel and from the hotel to and from the Race (defined below); tickets for the race scheduled to occur on November 6, 2026 (the "Race"); a gift bag for the winner; and \$3,000 gift card for the winner to use at their discretion for additional expenses. The approximate retail value ("ARV") of a prize is \$8,000. The actual value of a prize may vary depending on the point of departure, fluctuations in the cost of air transportation, and fluctuations in the cost of hotel accommodation. Any difference between the ARV and the actual value of a prize will not be awarded.

Sponsor reserves the right to structure travel routes, select hotels, and all other aspects of the prize in their sole and absolute discretion. Each winner is responsible for all travel expenses not included herein, including airline baggage fees, gratuities, meals, and any other incidental costs or expenses related to participation in the prize. In the event a winner elects to take part in the prize with no guest, no additional compensation will be awarded in lieu of the unused prize components. Once a guest is selected, he/she may not be substituted, except in Sponsor's sole and absolute discretion. Each guest must sign and return a travel liability release before travel will be booked. Each winner and guest hereby acknowledge that Sponsor has not and will not obtain or provide travel insurance or any other form of insurance for any part of a prize. No changes will be made to travel details once any element of the travel arrangements have been booked, except at Sponsor's sole discretion. Each winner will be required to provide a major credit card upon hotel check-in, and all in-room charges will be charged to the credit card. Any damage to the room will be the responsibility of the winner. Sponsor bears no responsibility if any event, element, or detail of the prize is canceled, postponed, or becomes unavailable for any reason whatsoever by the air carriers, hotels, venue operators, transportation companies, prize providers, or any other persons providing any prize-related services or accommodations. Sponsor is not liable for any missed prize events, or expenses incurred as a consequence of flight cancellation/delay or ground transportation delay. The venue operations management or other associated representative reserves the right in its sole discretion to remove or to deny entry to any winner and/or guest if either the winner or guest violates the previous restrictions or engages in an obnoxious, inappropriate, illegal, unsafe, or otherwise disruptive manner, or with intent to create an unauthorized disturbance or interruption, or to otherwise annoy, abuse, threaten, or harass any other person at any event.

All prize details not specified in these Official Rules will be determined in Sponsor's sole and absolute discretion. Prize details and availability are subject to change and are subject to applicable rules and restrictions. Prizes are awarded "AS IS" and without warranty of any kind, express or implied (including, without limitation, any implied warranty of merchantability or fitness for a particular purpose). Winners will be solely responsible for all federal, state, and/or local taxes, and for any other fees or costs associated with the prizes received, regardless of whether they, in whole or in part, are used. The value of the prize awarded to a winner will be reported for tax purposes as required by law. Each winner of a prize will be required to provide Sponsor with a valid social security number before the prize will be awarded for tax reporting purposes. An IRS Form 1099 will be issued in the name of each winner for the actual value of the prize received. Any unclaimed prize will be forfeited. Prizes, if legitimately claimed, will be awarded. The Offer Entities are not responsible for and will not replace any lost, mutilated, or stolen prize or any prize that is undeliverable or does not reach the winner because of an incorrect or changed address. If a winner does not accept or use the entire prize, the unaccepted or unused part of the prize will be forfeited, and the Offer Entities will have no further obligation with respect to that prize or portion of the prize. - 9. GENERAL:** Subject to applicable law, each winner hereby expressly grants to the Offer Entities and their respective successors, assigns, sublicensees and designees, the irrevocable right to use and

publish his/her name, social handles, likeness (photographic or simulated), voice, biography and place of residence for all purposes, including, without limitation, advertising, marketing, promotional and publicity purposes in connection with this Sweepstakes ("Advertising"), in any and all media now or hereafter devised, worldwide, in perpetuity, without any form of notice, permission or any amount or kind of compensation, except for the awarding of the prizes to the winners and fulfilling the Gifts to verified entrants. In the event that any provision of the Official Rules is determined to be invalid or otherwise unenforceable or illegal, the other provisions will remain in effect and will be construed in accordance with their terms as if the invalid or illegal provision were not contained herein. Sponsor's failure to enforce any term of these Official Rules will not constitute a waiver of that provision. Participants agree to waive any rights to claim ambiguity of these Official Rules. Headings are solely for convenience of reference and will not be deemed to affect in any manner the meaning or intent of the documents or any provision hereof. In the event there is a discrepancy or inconsistency between disclosures or other statements contained in any Sweepstakes-related materials, privacy policy or terms of use on any website, social media platform or application and/or the terms of the Official Rules, the Official Rules shall prevail, govern and control and the discrepancy will be resolved in Sponsor's sole and absolute discretion.
